**ORDER AMENDING CERTIFICATION**

Pursuant to the Decision and Order in *OSA, 8 OCB2d 19 (BOC 2015)*, an election was held by phone and on-line ballot in accordance with the Rules of the Office of Collective Bargaining (Rules of the City of New York, Title 61, Chapter 1) ("OCB Rules") § 1-02 for employees in the title Senior Consultant, Management Information Services, Level I (Title Code No. 985011), Level II (Title Code No. 985012), and Level III (Title Code No. 985013). ORDERED that Certification No. 3-88 (as previously amended) be, and the same hereby is, further amended to add the title Senior Consultant, Management Information Services, Level I (Title Code No. 985011), Level II (Title Code No. 985012), and Level III (Title Code No. 985013), subject to existing contracts, if any.
