**ORDER AMENDING CERTIFICATION**

On November 13, 2015, the Organization of Staff Analysts (“Union”) filed a petition pursuant to § 1-02(u) of the Rules of the Office of Collective Bargaining (Rules of the City of New York, Title 61, Chapter 1) requesting that the title Junior Clinical Business Analyst (Title Code No. 001440) be accreted to Certification No. 3-88, the Staff Analysts bargaining unit.

Notice of this petition was given to the public and NYC Health + Hospitals, and no objections were filed. The Board of Certification is satisfied that no evidence was presented to rebut the Union’s assertion that Junior Clinical Business Analysts have a sufficient community of interest with the members of its bargaining unit.

NOW, THEREFORE, pursuant to the powers vested in the Board of Certification by the New York City Collective Bargaining Law (New York City Administrative Code, Title 12, Chapter 3), it is hereby

ORDERED that Certification No. 3-88 (as previously amended) be, and the same hereby is, further amended to add the title Junior Clinical Business Analyst (Title Code No. 001440), subject to existing contracts, if any.
